¿Qué es ORCID?

- ORCID es una organización abierta y sin fines de lucro dirigida por y para la comunidad de investigación.
- ORCID proporciona a los investigadores un identificador único (y persistente), un ORCID iD, que los conecta de manera confiable y clara con sus contribuciones de investigación, afiliaciones, financiación e instalaciones.
- Un ORCID iD **NO** es un perfil de autor ni un control de autoridades
- ORCID proporciona herramientas abiertas (**ORCID iDs, Registro & APIs**) que permiten conexiones transparentes entre los investigadores y los identificadores de sus actividades y contribuciones.

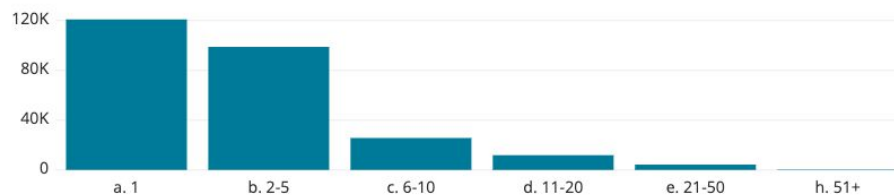

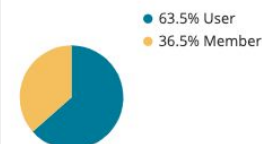
Funding added per year



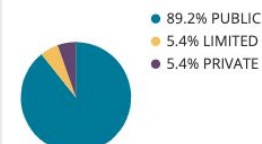

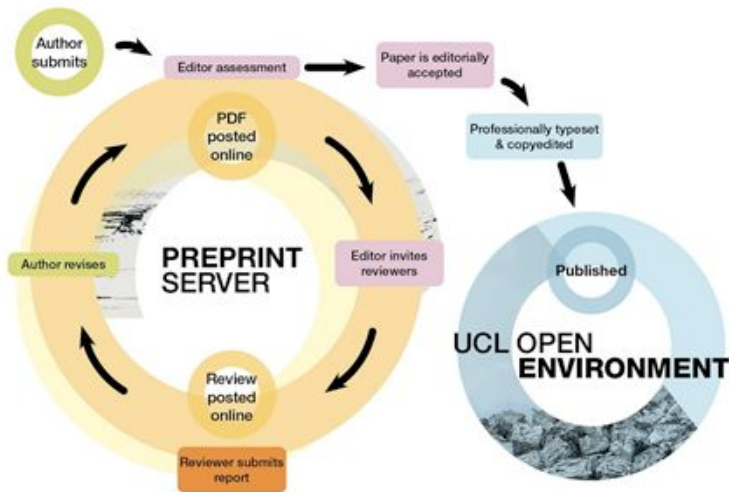

- To publish an open review reviewers must sign in via ORCID and must possess **five peer reviewed scholarly works associated in their ORCID account**.
- Reviewers are **invited by an Editor** and **authors are also free to invite** reviewers to review their paper openly.
- All open reviews must be conducted in line with *UCL Open* publishing, open peer review and open commenting policies
- Looking into co-contributor reviews.



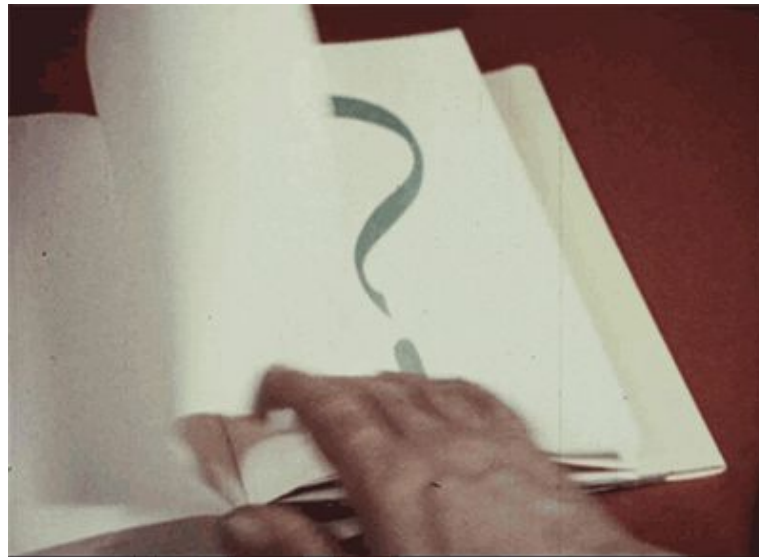
